1 About Us

1.1 Purpose / Objects

One Hope Centre was established in 2004 with the aim of helping people struggling with gambling addiction and related issues. In 2021, OHC expanded its service scope and now provides professional counselling and help services to people affected by a range of behavioural addictions, including gambling, shopping, sex, pornography, love and other addictions. The goal of its services is to support such individuals and families in their recovery from addiction and its harmful consequences, and in the rebuilding of their lives and relationships. Its clients consist of people across difference races, religions, age groups and nationalities.

One Hope Centre also seeks to create awareness of behavioural addictions through public education and engagement sessions. These initiatives serve as part of its outreach to potential help-seekers and partnership with practitioners in the social service and mental health sectors.

1.2 Overview of Charity

One Hope Centre ("OHC") was a registered as a society in August 2004.

OHC was registered as a charity under the Charities Act since 1 April 2010.

OHC has been accorded Institution of Public Character (IPC) status with effect from 1 August 2013. Its IPC status has been renewed and extended until 31 January 2025.

OHC has a Constitution as its governing instrument.



3 Highlights of the Year

3.1 Summary of Financial Performance

• Total Income: \$632,955

• Total Expenditure: \$538,731

• Net Income: \$94,224

The audited statement of accounts for the financial year 2023 is attached.

As at 31 Dec 2023, OHC has reserves of \$1,400,706 in its restricted and unrestricted funds.

3.2 Finance and Funding

OHC is financially supported by donations from individuals and organisations. It also receives government grants for some initiatives.

3.3 Programmes and Activities


3.3.1 Help Requests

In 2023, OHC received 230 help requests from individuals who sought support and assistance for issues related to addiction and other matters. This was a 20% increase compared to 2022, during which OHC received 192 help requests.

3.3.2 Counselling Programme

In 2023, OHC served a total of 102 clients in its counselling programme, out of whom 72 were newly enrolled during the year. 431 counselling sessions were conducted. Diagram 1 provides a breakdown of addiction issues faced by clients served during the year.





3.3.3 Other Activities

Between January 2022 and December 2023, OHC has established and connected with 17 other social service and government agencies as part of our referral network. It is an ongoing and growing initiative.



4 The Year Ahead

4.1 Future Plans and Commitments

In 2024, OHC plans to establish a satellite counselling base at the premise of Grace (SCC) Church at 14 Queen Street. This provides an alternative and more convenient location for clients to access its counselling services.

OHC also plans to hold a celebration event commemorating its 20th anniversary in August 2024, with the aim of re-connecting with partners and stakeholders and engaging them to continue supporting OHC's work.

4.2 Fundraising Plans for the Following Year

OHC plans to raise funds through engaging major donors and applying for grants that would help support the costs of programmes, activities, and capability-building projects.

5 Governance

5.1 Term Limit of Board

To enable succession planning and steady renewal in the spirit of sustainability of the charity, the Board has a term limit of 10 years. In particular, the Treasurer has a term limit of two years.

One member of the Board, Mr. Christopher Chuah Chee Kian, has served for more than 10 consecutive years on the board of One Hope Centre, for reasons of continuity and by virtue of his willingness to serve with institutional knowledge.

5.2 Board Meetings and Attendance

In 2023, the Board held 2 board meetings and one Annual General Meeting, with an average attendance rate of 68%. Appendix A lists the attendance of governing board members.

5.3 Disclosure on Remuneration

Governing board member are not remunerated for their services. One staff has received remuneration in the band between \$100,000 to \$200,000 during the year. There are no paid staff who are close family members of the Executive Head or board members.



5.4 Reserves Policy

OHC adopts a reserves policy of 2 years of operating expenses.

As at 31 Dec 2023, OHC has a ratio of funds to annual operating expenses of 2.42.

5.5 Conflict of Interest Policy

All Board members and staff are required to comply with OHC's conflict of interest policy.

The Board has put in place documented procedures for Board members and staff to declare actual or potential conflicts of interests on a regular and need-to basis.

Board members also abstain and do not participate in decision-making on matters where they have a conflict of interest.
